Entry fee: 30€ per dog. Withdrawing the announcement or absence does not exempt from the payment of the entry fee.

Parcours: medium heavy terrain, slope, for dogs with good condition! Distance: little Breeds ca. 600 - 700m, all other breeds ca. 800 – 1000 m

CACIL Regulations: Acc. To the FCI Regulations

CCLA: Acc. to the ÖKV Windhunde-Coursingsportordnung (2 showresults of 2 austrian shows have to be send with the entry form!!!!) Attention: It is also awarded a CCLA in the senior class from 6 years old!

2 runs according to the FCI Regulations. Class separation see entry form.

Two Dogs are challenging a run, the evaluation of the first run is basis of the division of the second round. If at least 6 dogs per race and gender are reported, males and females are separated. If there are less than 6 dogs of one sex reported, males and females will be mixed at the runs. There is no reclamation against the compilation and arrangement of the runs possible. No muzzle requirement for Italian Greyhounds.

The dog must have a valid, by FCI accepted, racing- or coursinglicence

Prizes CACIL/CCLA: Prizes for the 1. – 6. Place of each Breed

Prizes for the best dog and the winner of the day/Coursingclass (minimum three dogs a breed at start)
